Fall Meeting 9/09/2023

Luke Sternadel called the meeting to order at 5:15. He welcomed all members and thanked them for coming. He said a special thank you to Rob Cliff, manager of Camp Kubena, for allowing our organization to have our meeting here without charge.

The Fayette County 4-H Shooting Club was presented a check for \$1,000 by our co-op for purchasing supplies, improving their facilities and assisting in going to competitions. Two members introduced themselves and thanked our organization.

Laura Sherrod, wildlife biologist, reported Fayette County has a good deer population. Permits are being processed. There are no signs of chronic wasting disease. She spoke about things to do for wildlife exemption. The new game warden is Shaun Bayless.

Our first speaker was Donnie Dippel of CHB Consulting Inc. He spoke on things to do for wildlife management and food plots. He offered suggestions and ideas for improvement in these areas.

The second speaker was Jacob Hetzel of Texas Parks and Wildlife. He spoke on nuisance wildlife including feral hogs. He works in 10 counties and the most effort is spent on controlling feral hogs.

The final speaker, Will Hood of Texas A&M Forest Service spoke of the agency's response to wildfires.

Door prizes were given at various times during the meeting.

Mike Pietsch gave the table prayer.

A meal of fried chicken and the trimmings was served.

Bucket auction items were drawn during the meal.

Lana Limmer shared the history of the NCFCWMC's 30 year history which she researched and wrote.

The card for the gun raffle was drawn. Sue Schoenst won the gun.

The live auction was held.
